Pursuant to Va. Code 3.1-796.126:2, this animal must be sterilized if it has not been already. Failure to do so will result in a civil penalty not to exceed \$50. If the adopter fails to comply, the parties agree that he/she may be compelled to do so as provided in #3.1-796.

WHILE EVERY ATTEMPT IS MADE TO MEET THE MEDICAL NEEDS OF RESCUE ANIMALS, ANGEL DOGS CAN MAKE NO GUARANTEE AS TO THE HEALTH OF ANY ANIMAL.

ANGEL DOGS will not be responsible for payment of medical services provided any animal without prior approval by an authorized officer. ANGEL DOGS relinquishes responsibility for payment of medical care provided after an animal has been adopted.

SAFEHOUSING: I agree that the animal I foster will be physically returned to ANGEL DOGS by date set above or earlier upon request of ANGEL DOGS or if I am no longer able to care for the animal properly. I understand and acknowledge that I do not have any right or authority to keep, adopt, transfer or place a safehoused animal in other homes or with another individual.

ADOPTION: This agreement is made on the date noted above between the Adopter and ANGEL DOGS because:

1. Adopter desires to adopt and care for the animal described above as a companion animal.
2. ANGEL DOGS desires to have the animal placed in the home in which it will be fed and cared for to humane standards.

In consideration of the mutual covenants and promises enumerated below, the parties agree:

1. Adopter agrees to pay ANGEL DOGS the non-refundable fee specified above.
2. Adopter agrees to provide care and treatment for the companion animal to ensure its well-being.

This includes, but is not limited to: The animal shall have clean, dry, living quarters protected from extreme heat and cold, rain, sleet, snow, and wind. The animal shall not be chained, tied or caged for extensive periods of time. The animal shall be given sufficient care and attention. Fresh, clean water shall be provided daily. Appropriate food shall be available to the animal at least once a day. The animal shall be free from inhumane acts upon the body, such as, but not limited to striking with an implement, kicking, punching, maiming, mutilating or applying caustic substances. The animal shall not be used for medical or other research or experimental procedures, religious rituals or illegal activities. The animal shall receive appropriate medical care as required and all necessary vaccinations. No pet shall be restricted to outdoors.

3. Adopter/Safehouser agrees that if a representative from ANGEL DOGS determines that the standards of care as set forth above are not met, the adopter/safehouser will return the animal to ANGEL DOGS and relinquish future claim of right of possession.

4. Adopter agrees to comply with all state and county laws regarding licensing and vaccinations.

5. I agree to hold ANGEL DOGS harmless from any direct or consequential damages arising out of a safehouse or adoption agreement.
